the provisions contained in the affiliation & examination byelaws, directions issued from time to time and the law of the land.

- 8- That the school will ensure compliance of all statutory requirement like EPF, ESI and labour laws etc. with the school and staff of the school.
- 9- That the school will ensure that the building safety, Fire safety, Water safety, Health and hygiene certificates are being issued or renewed by the concerned or state authorities from time to time as per the prescribed term.
- 10- That the school will ensure that all required infrastructure is available with the school before starting classes.
- 11- That the school will ensure that sufficient number of qualified teachers as per the provisions contained in affiliation bye-laws are available with the school before starting classes.
- 12- That the school will follow the provisions related to fee contained in affiliation byelaws and will disclose details of the fee to the students/ parents every year before start of session without resorting to any hidden charges in the head of the fee.
- 13- That the school will not coerce any student/ parent to buy books/ stationery/ uniform from any particular shop.
- 14- That the school shall syrive to make efforts for conservation of environment.
- 15- That the school will ensure that school fulfills all essential requirement before applying for affiliation and will fulfill all other conditions post affiliation and comply with all the general rules as given in the affiliation byelaws or notified from time to time.
- 16- That in case affilatopn has benn with certain conditions, the school will not start CBSE pattern classes without submitting a certificate/ affidavit to the effect that the school has complied with all the condotions imposed by CBSE and the postaffiliations contained in affiliation byelaws along with general rules. (in case of school's application is under switch over please include the following clause in the affidavit.
- 17- That state pattern classes IX running prior to the affilaation in a phased manner. No admission will be taken in the state board pattern class IX to XII after getting affilaation from CBSE. The state Board School will be discontinued after switchover to CBSE.
